CATEGORIES OF MEMBERSHIP

LCI-UK has four membership categories:

- Individual
- Academic
- Corporate
- Student

Individual membership is open to everyone. The fee for an annual membership is £100 + VAT. An individual member has one vote at company meetings.

Academic membership is open to those working and/or studying at an academic institution in the UK and having an 'ac.uk' email address. At this time academic membership is £100 plus VAT. Each **academic institution** has one vote at company meetings.

Corporate membership is open to companies in the UK and allows for 10 members with full individual membership rights for a fee of £500 plus VAT.

Student membership is open to those studying at an academic institution in the UK and having an 'ac.uk' email address. At this time student membership is £30 (£25.00 + VAT). That is subject to change.
